8.I. Discussion / possible action regarding a columbarium built in the cemetery  
Public Works Director Rick Sailer gave a brief description of the columbarium and provided the board members with handouts of the options available. Chairperson Crowder noted that this would be a great opportunity as the number of cremations has increased significantly since COVID and often receives requests for this form of burial service.

Vice Chairperson Koopman made a motion to have Public Works pursue the columbariums by presenting this to Council. Board member Camacho seconded. **MOTION CARRIED UNANIMOUSLY.**

8.II. Discussion / possible action regarding appointing a dedicated sexton to maintain the cemetery

Vice Chairperson Koopman expressed the need to take pride in the cemetery as it is a "memorial park" and should have a designated member to take ownership over the maintenance of the gravesites. Chairperson Crowder also noted that this could take away the concern of misplacement of gravesites since one person would be in charge.

Vice Chairperson Koopman made a motion to recommend the creation of a part-time position for a sexton to properly maintain the cemetery. Board member Camacho seconded. **MOTION CARRIED UNANIMOUSLY.**

8.III. Discussion / possible action regarding Veterans Day on November 11, 2024

Board member Camacho made the suggestion to have an event to allow more community involvement. His idea is to create awareness and visibility of the Cemetery Board and wants to honor all who have served on Veterans Day. The board is in support of this idea but needs to clarify the event parameters. Chairperson Crowder designated board member Camacho to chair this event and requested to have a planning discussion at the next board meeting.

Board member Camacho made a motion to have a Veterans Day event. Board member Johnson seconded. **MOTION CARRIED UNANIMOUSLY.**
