3.1. Water Initiatives Round Up Program

Celina Gauthier Lowry (Texas A & M Extension Program Specialist) presented on the Texas Community Watershed Partners program. She shared that this program is grant funded through the Texas General Land Office and Coastal Management. The program is currently working with a group called the Galveston Bay Coalition of Watershed with a focus on the water quality in the surface water of the local bayous and bay, and ultimately going to the Gulf. She promoted an event on May 20th from 9:00 a.m. to 11:00 a.m. located at the Dickinson Historic Railroad Depot, which is meant to bring together the keep beautiful groups from four (4) watershed areas with a focus on supporting outreach related to water quality and the environment.

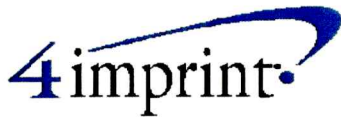

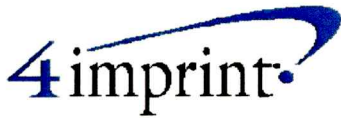

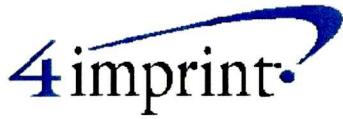
