Highland Bayou Park Mural Overview

The proposed project consists of two mural walls, each measuring approximately 23 feet wide by 8 feet high.

Option 1 – Both Walls Completed Simultaneously

- Wall 1: \$1,700
- Wall 2: \$1,700
- Total Project Cost: \$3,400

By completing both murals during the same project timeline, costs can be reduced through shared setup, travel, material procurement, and production efficiency.

Option 2 – Walls Completed on Separate Timelines

- Wall 1: \$2,000
- Wall 2: \$2,000
- Total Project Cost: \$4,000

If the murals are completed as separate projects, an additional charge is required due to:

- Additional design and project management time for coordinating two separate project schedules.
- Repeated site visits, travel expenses, and equipment setup.
- Separate material purchases and mobilization costs.
- Loss of production efficiency that comes from completing both murals during the same installation period.
- Increased administrative time for project coordination, invoicing, and scheduling.

Combining both walls into a single project timeline provides the most cost-effective option while maintaining the same level of quality and artistic execution.
