In accordance with Section 551.127(b) of the Texas Government Code the presiding officer and a quorum of the La Marque City Council intend to be and will be physically present at 1109-B Bayou Road, La Marque, Texas. Taxpayer Impact Statement Required per H.B. 1522 effective September 1, 2025

While this statement is required under the new legislation it is too early in the process to include any figures. The City provides the following information in compliance with Texas Government Code § 551.043(c):

2025 Adopted Tax Rate \$0.418501 with average homestead taxable value of \$215,569 equals tax of \$902.16

2026 No-New-Revenue Tax Rate is \$0.398957

2026 Proposed Tax Rate \$0.398957 with average homestead taxable value of \$229,515 equals tax of \$915.67

The change in total tax rate is -.019544 per \$100, or -4.6%

The change in average homestead taxable value is an increase of 6.5%

The change in tax on average homestead is an increase of \$13.51 or 1.5%
